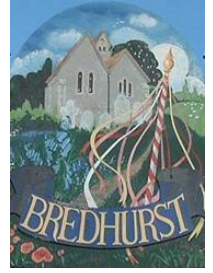


## **BREDHURST PARISH COUNCIL**
